**FOR PG 3<sup>rd</sup> SEMESTER 2025**

It is hereby notified that the following procedure will be followed for the Students obtaining supplementary in MOOC in PG 3rd Semester Examinations 2025.

**Category A: Students who could not register, submit minimum number of Internal Assessment (IA) or qualify in IA.**

1. The departments concerned will select an appropriate 4-credit MOOC from the January-June 2026 SWAYAM cycle.
2. Students need to complete the entire MOOC and appear in the End-Semester Examination conducted by SWAYAM / NPTEL / NTA.
3. After successful completion, students shall submit their SWAYAM Certificate for credit integration into PG 3<sup>rd</sup> semester result.

**Category B: Students who submitted minimum number of Internal Assessment (IA), passed IA but failed or did not appear in the University-conducted MOOC Examination**

1. These students need to appear in a Supplementary MOOC examination conducted by the concerned University authority along with PG 4<sup>th</sup> semester following the same syllabus, evaluation structure and approved procedural guidelines.
2. Their IA marks will be carried forward as per existing regulations

**FOR MARKSHEET AND TAB SHEET**

Students must submit a minimum of 75% IA, secure 40% marks in IA and End Semester Examination of the same MOOCs Paper separately to be considered as **PASS** in the MOOC paper.
