<u>Resolution</u>: The Executive Council (EC) of Vidyasagar University noted that the EC in its earlier meeting held on 22.12.2021 during the discussion of release of Dr. Siddhartha Sankar Dash from the post of Medical Officer of Vidyasagar University as voluntary retirement decided that due to the emergent situation of vacancy of the Medical Officer of this University, a Part-time Medical Officer purely on hiring basis may be recruited immediately. The Executive Council noted further the detailed employment notification drafted by the office of the Registrar based on such a decision for publication in the local newspapers and also the University website for recruitment of the said post.

After thorough discussion on the draft Employment Notification prepared for appointment of contractual position of Medical Officer of Vidyasagar University, it was resolved that the said draft employment notification for this purpose be accepted and published for this purpose as per the norms of the University. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

To place before the Executive Council of Vidyasagar University, the Notification bearing Memo No. 08-Edn(U)/1U-01/2022 dated 04.01.2022 issued by the Deputy Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding inclusion of five diseases in the list of infectious disease, like, (a) SARS, (b) MARS, (c) COVID-19, (d) Avian Influenza (H5N1)/Novel Influenza and (e) Crimean Congo Hemorrhagic Fever (CCHF) etc. under Leave Rule 22(b) under annexure of G.O. No. 44-Edn(U) dated 28.01.2008 read with 762-Edn(CS)/2L-10/08 dated 03.12.2009 and the Leave Rules as incorporated in the Statutes of all the State-aided Universities, in addition to the existing diseases specified therein.

The Executive Council of Vidyasagar University noted the **Resolution:** Notification bearing Memo No. 08-Edn(U)/1U-01/2022 dated 04.01.2022 issued by the Deputy Secretary to the Government of West Bengal, Department of Higher Education, University Branch stating that in consequence of presence of an infectious disease in the family or household of a regular and whole-time Nonteaching employee of all State-aided Universities at his/ her office, his/her place of duty, residence or sojourns is considered as hazardous to the health of other coemployees, such teacher, non-teaching staff and any other employee of the Stateaided Universities may be granted quarantine leave. Such leave may be granted on the basis of a certificate of a Public or Municipal Health Officer or Registered Medical Practitioner for a period not exceeding 21 days, or in exceptional circumstances for a period not exceeding 30 days. The Executive Council noted also that the Quarantine leave will be treated as absent from duty with full pay and allowances, when he/she is ordered by the Head of the State-aided University. The Executive Council noted further that now after careful consideration and taking the valued opinion of the Health and Family Welfare Department of the Government of West Bengal five diseases, like, (a) SARS, (b) MARS, (c) COVID-19, (d) Avian Influenza (H5N1)/Novel Influenza and (e) Crimean Congo Hemorrhagic Fever (CCHF) etc. are hereby included under Leave Rule 22(b) under annexure of G.O. No. 44-Edn(U) dated 28.01.2008 read with 762-Edn(CS)/2L-10/08 dated 03.12.2009 and the Leave Rules as incorporated in the Statutes of all the State-aided Universities, in addition to the existing diseases specified therein. After thorough discussion on the notification issued by the Deputy Secretary to

the Government of West Bengal, Department of Higher Education, University Branch regarding inclusion of five diseases in the list of infectious disease, like, (a) SARS, (b) MARS, (c) COVID-19, (d) Avian Influenza (H5N1)/Novel Influenza and (e) Crimean Congo Hemorrhagic Fever (CCHF) etc. under Leave Rule 22(b) under annexure of G.O. No. 44-Edn(U) dated 28.01.2008 read with 762-Edn(CS)/2L-10/08 dated 03.12.2009 and the Leave Rules as incorporated in the Statutes of all the State-aided Universities, in addition to the existing diseases specified therein, it was resolved that the said Notification of the Higher Education Department be accepted and the aforesaid notification of the Higher Education Department dated 04.01.2022 be executed in this University for the aforementioned infectious diseases including COVID-19 disease and the quarantine leave may be granted to all employees of Vidyasagar University in case of such infectious diseases on the basis of a certificate of a Public or Municipal Health Officer or Registered Medical Practitioner for a period not exceeding 21 days, or in exceptional circumstances for a period not exceeding 30 days. Resolved further that such quarantine leave be treated as absent from duty with full pay and allowances, when he/she is ordered by the Head of the University as advised by the Higher Education Department. Resolved again that the Registrar and the Establishment Section of this University be requested to process further regarding this.
