After thorough discussion on the list of intake capacity of the general courses of B.A./B.Sc./B.Com. of different colleges affiliated to Vidyasagar University for the academic session 2021-2022, it was resolved that the said list of intake capacity of different general courses as proposed by the Inspector of Colleges be accepted and the Inspector of Colleges be requested to process further to communicate the same to the concerned colleges in discussion with the Secretary, Council for Undergraduate Studies of this University in this regard.

To place before the Executive Council of Vidyasagar University, the letter dated 12.07.2021 submitted by Sk. Ali Hossain, Accountant of Vidyasagar University in reply to the censure letter issued by the University to him for putting the unauthorized statements/notes on the official documents (particularly on bills) of DDE beyond his power.

Resolution: The Executive Council of Vidyasagar University noted that in terms of the decision taken by the Executive Council of Vidyasagar University in its Fifth meeting held on 24.05.2021 based on the recommendation of the Advisory Committee of the Directorate of Distance Education (DDE) taken in its 156th meeting held on 20.04.2021 and duly forwarded by the Director of DDE, a censure letter was issued to Sk. Ali Hossain, Accountant of Vidyasagar University for putting unauthorised statements/notes on the official documents (particularly on bills) of DDE beyond his power and the letter of censure also be recorded in his Service Book. The Executive Council noted further that in reply to the aforesaid censure letter, Sk. Hossain has submitted a letter dated 12.07.2021 praying for re-consideration of the decision of censure and also recording in Service Book as decided by the Executive Council in its meeting held on 24.05.2021. After thorough discussion on the letter submitted by Sk. Ali Hossain, Accountant of Vidyasagar University praying for re-consideration of the decision of censure and also recording in the Service Book, it was resolved that the decisions taken by

the Executive Council in its earlier meeting in this regard be reconsidered and further resolved as follows :

(1) the censure letter as was issued in favour of Sk. Ali Hossain be withdrawn.

(2) a warning letter for not repeating the practice for putting the unauthorised statements/note on the official documents (particularly on Bills) of DDE beyond his power be issued in favour of Sk. Hossain and the same be preserved in his personal file.

(3) the Registrar and the Establishment Section of this University be requested to process further in this regard.

To consider the letter dated 23.07.2021 submitted by Shri Khokan Maity, Audit Officer (on lien) of Vidyasagar University praying for extension of lien period for a period of one year with effect from the date of his release from Vidyasagar University.

<u>Resolution</u>: The Executive Council of Vidyasagar University noted that in terms of the decision taken by the Executive Council of Vidyasagar University in its Sixth meeting held on 30.06.2021 based on the prayer submitted by Shri Khokan Maity, he was granted leave with lien for a period of three months from his date of release at Vidyasagar University for joining the post of Finance Officer of Bankura University and accordingly he released from the University with effect from the afternoon of 19.07.2021. The Executive noted further that now he has submitted a letter dated 23.07.2021 through mail requesting for extension of the lien period for one year for this purpose as he would be under probation for one year at Bankura University.

After thorough discussion and careful consideration of the letter submitted by Shri Khokan Maity praying for extension of lien period for a period of one year with effect from the date of his release from Vidyasagar University, it was resolved that the lien period for three(03) months as was granted earlier to Shri Maity for joining the post of Finance Officer of Bankura University be extended for a further period of three (03) months after the date of expiry of the first term lien, i.e. from 19.10.2021.Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

To consider the letter dated 22.07.2021 submitted by Professor Raj Kumar Kothari, Professor (on lien), Department of Political Science of Vidyasagar University praying for extension of lien period for a period of one year with effect from the date of his release from Vidyasagar University.

Resolution: The Executive Council of Vidyasagar University noted that in terms of the decision taken by the Executive Council of Vidyasagar University in its Sixth meeting held on 30.06.2021 based on the prayer submitted by Professor Kothari, he was granted leave with lien for a period of three(03) months from his date of release at Vidyasagar University for joining the post of Professor of Political Science at Diamond Harbour Womens' University. The Executive Council noted further that now he has submitted a letter dated 22.07.2021 through mail requesting for extension of the lien period at least one year for this purpose as he would be under probation for one year at his new institution.

After thorough discussion and careful consideration of the letter submitted by Professor Raj Kumar Kothari praying for extension of lien period for a period of one year with effect from the date of his release from Vidyasagar University, it was resolved that the lien period for three(03) months as was granted earlier to Professor Kothari for joining the post of Professor of Political Science at Diamond Harbour Womens' University be extended for a further period of three (03) months

after the date of expiry of the first term lien, i.e. from 19.10.2021. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

<u>Resolution:</u> The Executive Council of Vidyasagar University noted the letter dated 23.07.2021 submitted by Dr. Biswapati Jana, Associate Professor & Head, Department of Computer Science of Vidyasagar University stating that the Departmental Committee of the Computer Science Department in its meeting held on 20.07.2021 decided to re-start the admission process for Ph.D. in Computer Science from the academic year 2021-2022 considering the present achievements of the particular department for the benefits of the faculty members as well as the scholars who are looking for the opportunity to do research and contribute to the advancement of the University on the global map of Higher Education. In this connection he has requested to consider the same.

After thorough discussion on the letter submitted by the Head, Department of Computer Science of Vidyasagar University praying for re-starting the admission process for Ph.D. Programme in Computer Science from the academic year 2021-2022, it was resolved that the said proposal of the Department of Computer Science duly recommended by the Departmental Committee of Computer Science be accepted and the admission of Ph.D. Programme in Computer Science be included in the admission notification of various Ph.D. Programmes of Vidyasagar University for the academic session 2021-2022 already notified and published. Resolved also that the matter is to be noted in the meeting of the Board of Research Studies of Vidyasagar University in this regard. Resolved further that the Registrar and the Ph.D. Cell of Vidyasagar University be requested to process further in this regard.

To consider the letter bearing No. EIILM-Kol/REG/02/2021 dated 28.07.2021 submitted by the Chairman & Director, Eastern Institute for Integrated Learning in Management (EIILM), Kolkata pertaining to nomination of the University Nominees to the Advisory Committee to be constituted for the Bachelor of Business Administration (BBA) Programme run by EIILM.

<u>Resolution</u>: The Executive Council of Vidyasagar University noted the letter bearing No. EIILM-Kol/REG/02/2021 dated 28.07.2021 submitted by the Chairman & Director, Eastern Institute for Integrated Learning in Management (EIILM), Kolkata along with the compliance report accepting the terms & conditions for running the Bachelor of Business Administration (BBA) Programme for which the affiliation was extended to them requesting for sending the names of three persons to be nominated by the Executive Council for formation of the Advisory Committee for the aforesaid programme.

After thorough discussion on the letter along with the compliance report submitted by the Chairman & Director, Eastern Institute for Integrated Learning in Management (EIILM), Kolkata requesting the nominees of the Executive Council for formation of the Advisory Committee for running the BBA course, it was resolved that three members be nominated for this purpose and regarding nomination of persons to the Advisory Committee, the matter be left to the Hon'ble Vice-Chancellor in this regard.

To discuss the matter regarding conduction of the next Annual Convocation (22nd) of Vidyasagar University on 29th September, 2021, the University Foundation Day.

Resolution: The Executive Council of Vidyasagar University noted that the Ninth Court of Vidyasagar University in its First meeting held on 01.10.2020 on the recommendation of the Executive Working Committee of Vidyasagar University decided that the next Annual Convocation (22nd) of Vidyasagar University be held on 29.09.2021 where two years (i.e. 2020 & 2021) degrees/diplomas/endowments/ medals etc. to be awarded as it was not possible to hold the said Convocation in the year 2020 due to non-feasibility of preparation of huge tasks required for Convocation & not finalization and publication of the results of the University for the year 2020 and also maintaining the social distance norms during the pandemic and outbreak situation of COVID-19. The Executive Council noted also that the decision of the Court was also noted in the first meeting of the Ninth Executive Council of Vidyasagar University in its meeting held on 05.10.2020. The Executive Council noted further that now the second wave of the pandemic and outbreak situation of COVID-19 is going on and the University is functioning following the restriction measures stipulated/adopted by the Government of West Bengal from time to time. A fruitful decision in the matter of conducting the next Convocation (22nd) on 29th September, 2021 may kindly be taken.

After thorough discussion on the matter regarding conduction of the next Annual Convocation (22nd) of Vidyasagar University on 29th September, 2021, the University Foundation Day, it was resolved that considering the restriction measures stipulated/adopted by the Government of West Bengal time to time due to ongoing second wave of pandemic situation of COVID-19 and also maintaining the social distance norms, the Twenty-Second (22nd) Convocation of Vidyasagar University can not be held on 29th September, 2021 and the matter be brought to kind notice of the Higher Education Department, Government of West Bengal for their information and necessary advice, if any, in this regard. Resolved also that the decision of the Executive Council be also forwarded to the Court of Vidyasagar University for approval. Resolved further that the Registrar be requested to process further in this regard.

06(k)

To discuss the suggestions duly recommended by the Enquiry Committee constituted based on the allegations made by Sk. Ali Hossain, Accountant and Shri Uttam Kumar Saha, Technical Assistant (Contractual), Department of Electronics of Vidyasagar University against each of them regarding Bankim Chandra Abasan related matters, in their report.

<u>Resolution</u>: The Executive Council of Vidyasagar University noted that the Enquiry Committee constituted based on the allegations made by Sk. Ali Hossain, Accountant and Shri Uttam Kumar Saha, Technical Assistant (Contractual), Department of Electronics of Vidyasagar University against each of them regarding Bankim Chandra Abasan related matters, submitted a detailed report alongwith their recommendations/suggestions which was accepted by the Executive Council of Vidyasagar University in its 3rd meeting held on 27.01.2021 and took some decisions in its further meeting dated 30.06.2021. The Executive Council noted further that as desired by the Hon'ble Vice-Chancellor, now, the recommendations/suggestions made by the Committee in their report are placed again before the Executive Council for further consideration. The Executive Council noted also from the said enquiry report that that you used some social and communal language/issues while discussing to others over telephone in the Abasan premises which was not desired from an employee.

After thorough discussion on the enquiry report submitted by the Enquiry Committee constituted based on the allegations made by Sk. Ali Hossain, Accountant and Shri Uttam Kumar Saha, Technical Assistant (Contractual), Department of Electronics of Vidyasagar University against each of them regarding Bankim Chandra Abasan related matters further, it was resolved as follows:

- (a) Shri Uttam Kumar Saha be cautioned/warned not to repeat such type of communal language/issues during discussion with anybody in the University premises and to refrain from this in near future.
- (b) Shri Saha be advised to vacate the Unit No. 23 of Bankim Chandra Abasan of Vidyasagar University, presently occupied by him, within three (03) months from the date of receipt of this letter and he would be re-allotted another quarter/hostel/unit as per the availability of the University for this purpose.

06(1) To consider the letter dated 15.08.2021 submitted by Dr. Raj Kumar Kothari, Professor (On lien), Department of Political Science of Vidyasagar University praying for necessary corrections/changes in his Service Book at Vidyasagar University.

Resolution: Consideration of the item was deferred.

To consider the letter dated 14.07.2021 submitted by Shri Bulbul Mahapatra, Security Guard of Vidyasagar University praying for granting of leave during the period from 28.05.2021 to 12.07.2021 taken by him for suffering from COVID-19. <u>Resolution:</u> The Executive Council of Vidyasagar University noted the letter dated 14.07.2021 submitted by Shri Bulbul Mahapatra, Security Guard of Vidyasagar University alongwith the medical supporting documents praying for granting of leave during the period from 28.05.2021 to 12.07.2021 totaling 46 days leave taken by him for suffering from COVID-19 disease. The Executive Council noted further the medical documents submitted by Shri Mahapatra alongwith his aforesaid prayer in support of his illness.

After thorough discussion on the prayer submitted by Shri Mahapatra and careful consideration of the medical supporting documents pertaining to granting of leave during the period from 28.05.2021 to 12.07.2021 taken by him for suffering from COVID-19, it was resolved that the leave as prayed for by Shri Mahapatra be granted to him as per the norms of the University for this purpose as resolved in the meeting vide item No. 06(q) that maximum Twenty-one (21) days of Quarantine Leave as specified under Section 128 of the Vidyasagar University First Ordinances, 1985 as amended by the West Bengal University Laws (Amendment) Ordinance, 2011, be granted to an employee for such infectious diseases subject to submission of NEGATIVE Report from the appropriate department and the rest of the leave, if required for this purpose, may be granted as medical leave. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

06(n)

To consider the letter dated 23.08.2021 submitted by Shri Gautam Pal, Finance Officer of Vidyasagar University praying for counting of his past service including credit of leave at Vidyasagar University for continuity of service.

<u>Resolution:</u> The Executive Council of Vidyasagar University noted that Shri Gautam Pal joined Vidyasagar University as Finance Officer with effect from the forenoon of 04.09.2018. Before that he served at Bidhan Chandra Krishi Viswavidyalaya as Comptroller and was released from his previous employer with effect from the afternoon of 31.08.2018 for this purpose. He was released by

his previous employer, Bidhan Chandra Krishi Viswavidyalaya, with effect from the afternoon of 31.08.2018 without granting of lien nor any leave without pay for joining the post of Finance Officer of Vidyasagar University. The Executive Council noted also that the Vidyasagar University recorded his date of joining notionally with effect from 01.09.2018, prefixing the holidays, i.e. 01.09.2018, 02.09.2018 & 03.09.2018 (Saturday, Sunday and the Janmastami, Public holiday. Vidyasagar University gave him the benefit of continuation of service on the holidays, i.e. 01.09.2018, 02.09.2018 & 03.09.2018 (Saturday, Sunday and the Public Holiday on the occasion of Janmastami) preceding his date of joining i.e. with effect from 31.08.2018. Thereafter, the Higher Education Department, Government of West Bengal based on the prayer of Shri Pal for providing the financial benefit of salary from 01.09.2018 to 03.09.2018 duly forwarded by the Executive Council declined the prayer of Shri Pal stating that the joining of Shri Pal to the post of Finance Officer on 04.09.2018 is a fresh appointment, his claim for salary for the first three days from 1st September to 3rd September, 2018 is not admissible. The Executive Council noted further that the EC in its meeting held on 30.06.2021 accepted his original service book received from his previous employer. The Executive Council noted again that now Shri Pal has sent a letter dated 23.08.2021 praying for counting his past service with effect from 13.11.2006 including credit of leave for entitlement of the benefits related to pension and other retirement benefits at Vidyasagar University.

After thorough discussion on the letter submitted by Shri Gautam Pal, Finance Officer of Vidyasagar University praying for counting of his past service including credit of leave at Vidyasagar University for continuity of service, it was resolved that the prayer of Shri Pal be accepted in principle and the matter be brought to the kind notice of the Higher Education Department, Government of West Bengal for opinion/advice and necessary concurrence in this regard. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

To place before the Executive Council of Vidyasagar University, the letter bearing No. HED-12016(45)/6/2021-UNV SEC-Dept. of HE dated 18.08.2021 received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding payment of arrear salary in respect of Dr. Brajaballav Pal, Associate Professor, Department of Commerce, Vidyasagar University.

The Executive Council of Vidyasagar University noted that Dr. Resolution: Brajaballav Pal joined at Vidyasagar University on 20.03.2012 as Assistant Professor in the Department of Commerce and at present holding the post of Associate Professor in the same Department. Before joining this University, he served at Panskura Banamali College from 01.09.2006 to 19.03.2012. Dr. Pal obtained his Ph.D. Degree on 17th December, 2002. He submitted a letter dated 17.03.2021 praying for his arrear salary counting the Ph.D. incentives during the period from 01.09.2006 to 19.03.2012 served at Panskura Banamali College as Dr. Pal did not receive the said benefit from that college during his service period. The Executive Council noted also that the matter was forwarded to the Higher Education Department, Government of West Bengal for their opinion in this regard. The Executive Council noted further that in reply to that now we have received a letter bearing No. HED-12016(45)/6/2021-UNV SEC-Dept. of HE dated 18.08.2021 from the Assistant Secretary to the Government of West Bengal, Higher Education Department stating that the arrear salary counting the Ph.D. incentives in respect of Dr. Pal during his tenure as Assistant Professor, Panskura

Banamali College may not be released from the University. DPI pay packet cell may allot the fund to the college where he served earlier. The college may release the payment through e-pradan.

After thorough discussion on the letter received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding payment of arrear salary in respect of Dr. Brajaballav Pal, Associate Professor, Department of Commerce, Vidyasagar University, it was resolved that a copy of the said G.O. be forwarded to the incumbent concerned, the Finance Officer of Vidyasagar University and the Principal of Panskura Banamali College for necessary action as advised by the Higher Education Department. Resolved further that the Registrar be requested to process further in this regard.

To consider the letter bearing No. VUAA/03/2021 dated 19.08.2021 submitted by the Secretary, Vidyasagar University Alumni Association (VUAA) praying for allocation of a space in the campus for erecting a piece of sculpture.

<u>Resolution</u>: The Executive Council of Vidyasagar University noted the letter bearing No. VUAA/03/2021 dated 19.08.2021 submitted by the Secretary, Vidyasagar University Alumni Association (VUAA) stating that the Board of Directors of that association has decided to erect a piece of sculpture in a prominent place in the campus of Vidyasagar University. The proposed sites are Near Administrative Building or Near UCO Bank. This piece of sculpture will enhance the scenic beauty of the campus. In this connection he has requested to accord necessary approval in this regard.

After thorough discussion on the letter submitted by the Secretary, Vidyasagar University Alumni Association (VUAA) praying for allocation of a space in the campus for erecting a piece of sculpture, it was resolved that the said proposal of the Secretary be forwarded to the Space, Planning and Development Committee of Vidyasagar University which will be re-constituted very soon and the matter is left to the Hon'ble Vice-Chancellor, for necessary action in this regard. Resolved further that the Development Officer of this University be requested to process further in this regard.

06(q)

To discuss the matter regarding granting of leave in case of infectious diseases like SARS, MARS, COVID-19, Avian Influenza (H5N1)/Novel Influenza and Crimean Congo Haemorrhagic Fever (CCHF).

Resolution: The Executive Council of Vidyasagar University noted a note-sheet put forward by the Establishment Section of Vidyasagar University regarding the policy decision for granting of leave in case of infectious diseases like COVID-19. The Executive Council also noted the Memorandum bearing No. 3230-F(P1) dated 18.11.2020 issued by the Principal Secretary to the Government of West Bengal, Finance Department, Audit Branch wherein it was stated that Rule 198 of WBSR, Pt-I provides for the grant of Quarantine Leave to a Government employee when he/she or any member of his/her family is affected by such infectious disease as specified thereunder as his /her attendance at office/place of duty is considered hazardous to other government employees. With the passage of time, outbreak of some other diseases in the country had been considered to be infectious of which COVID-19 has been declared Pandemic by WHO for the year 2020. The Executive Council noted further that after careful consideration and taking the valued opinion of the Health & Family Welfare Department of the Government of West Bengal, the diseases of SARS, MARS, COVID-19, Avian Influenza (H5N1)/Novel Influenza and Crimean Congo Haemorrhagic Fever (CCHF) have been included in the list of infectious disease under the said WBSR rule in addition to the existing

diseases. In case of such infectious diseases quarantine leave may be granted to an employee. The Executive Council noted again that in terms of Section 128 of the Vidyasagar University First Ordinances, 1985 as amended by the West Bengal University Laws (Amendment) Ordinance, 2011, the Quarantine leave may be granted for infectious diseases on the basis of certificate of the Public Health Officer or registered Medical Practitioner for a period not exceeding 21 days or in exceptional circumstances 30 days.

After thorough discussion on the note put forward by the Establishment Section regarding policy decision for granting of leave in case of infectious diseases like SARS, MARS, COVID-19, Avian Influenza (H5N1)/Novel Influenza and Crimean Congo Haemorrhagic Fever (CCHF) and subsequently the Memorandum bearing No. 3230-F(P1) dated 18.11.2020 issued by the Principal Secretary to the Government of West Bengal, Finance Department, Audit Branch Memorandum for inclusion of five diseases like, SARS, MARS, COVID-19, Avian Influenza (H5N1)/Novel Influenza and Crimean Congo Haemorrhagic Fever (CCHF) etc. in the list of infectious disease under Rule 198 of WBSR, Pt.-I in addition to existing diseases, it was resolved that maximum Twenty-one (21) days of Quarantine Leave as specified under Section 128 of the Vidyasagar University First Ordinances, 1985 as amended by the West Bengal University Laws (Amendment) Ordinance, 2011, be granted to an employee for such infectious diseases subject to submission of NEGATIVE Report from the appropriate department and the rest of the leave, if required for this purpose, may be granted as medical leave.

06(r)

To consider the letter dated 06.07.2021 submitted by Professor Debasish Bandyopadhyay, Professor (On lien), Department of English of Vidyasagar University pertaining to extension of lien period for a further period of three months with effect from 1st July, 2021.

Resolution: The Executive Council of Vidyasagar University noted that Professor Debasish Bandyopadhyay, Professor (On lien), Department of English of Vidyasagar University and now Professor, Department of English at the Rabindra Bharati University was granted lien initially for a period of three months with effect from 01.04.2021 for joining the post of Professor at the Rabindra Bharati University which has already been expired on 30.06.2021. Thereafter Professor Bandyopadhyay prayed for extension of his lien period for a further period of six months so that it covers his probationary period of 12 months at Rabindra Bharati University. After that he requested again to extend his lien period for another 3 months with effect from 1st July, 2021 in view of the abnormal situation prevailing with the lockdown in force and he suffering from COVID and other ailments and his aforesaid prayer was declined by the Executive Working Committee of Vidyasagar University in its meeting held on 04.06.2021. The Executive Council noted further that now Professor Bandyopadhyay has submitted again a letter dated 06.07.2021 praying for re-consideration of the decision taken by the Executive Working Committee and extend his lien period for another three months with effect from 1st July, 2021.

After thorough discussion and after careful consideration of the letter submitted by Professor Debasish Bandyopadhyay, Professor (On lien), Department of English of Vidyasagar University pertaining to extension of lien period for a further period of three months with effect from 1st July, 2021 and subsequently the decision taken by the Executive Working Committee of Vidyasagar University earlier regarding extension of lien, it was resolved that the lien period as was granted to Professor Bandyopadhyay initially towards his joining as Professor of English at the Rabindra Bharati University be extended for a further period of

three (03) months with effect from 1st July, 2021. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

To place before the Executive Council of Vidyasagar University, the decision taken by the Advisory Committee of DDE (Directorate of Distance Education) of Vidyasagar University in its 157th meeting [vide item No. 2(d)] held on 18.08.2021 regarding sanctioning of leave in favour of Chanchal Mukherjee, Driver (Contractual), DDE.

<u>Resolution</u>: The Executive Council of Vidyasagar University noted that the Advisory Committee of DDE in its 157th meeting held on 18.08.2021 after careful consideration of the matter regarding sanctioning of leave in favour of Shri Chanchal Mukherjee, Driver (Contractual), DDE approved 14 days leave with full pay in favour of him and the rest of the days of his absence granted as leave without pay. The Executive Council noted further that the Advisory Committee in its aforesaid meeting further decided based on the proposal submitted by the IQAC for the welfare of contractual employees of Vidyasagar University as (i) for DDE contractual employees 20% of the medical expenses or Rs.5,000/-, whichever is lesser, be re-imbursed on production of original bills alongwith medical prescription and (ii) if any accident or medical problem is caused in a contractual employee of DDE during in service/on-duty condition, 25% of the medical expenses or Rs.6,000/-, whichever is lesser, be re-imbursed on production original bills alongwith medical prescription and the matter be placed before the Executive Council for consideration.

After careful consideration of the decision taken by the Advisory Committee of the Directorate of Distance Education (DDE) of Vidyasagar University regarding providing the welfare to the contractual employees of Vidyasagar University including DDE, it was resolved that the following welfare on medical ground for the contractual employees of the University including DDE be provided henceforth:
