Feedback Obtained

The feedback on the university is regularly obtained from the following categories of respondents and analyzed in a scientific manner, which is then utilized for improving further in different sectors of the University. The entire process is executed in the following manner: ? First, the feedback forms are distributed among the following categories of stakeholders, namely, a) Students b) Teachers c) Parents d) Officers e) Employees f) Alumni g) Employers . ? Second, the above forms have a set of structured questionnaires to be analyzed in a five (5) point scale (1Poor, 2 Average, 3 Good, 4 Very Good, 5 Excellent). ? Third, among the above stakeholders, five categories of respondents, namely, Students, Teachers, Officers, Employees and Alumni send their responses through online. The others two categories of Students respondents register their responses through offline mode. ? Fourth, the feedback forms are analyzed in both numerical and graphical modes. After a thorough analysis of the responses from the above stakeholders, the University utilizes the information gathered for overall development of the institution in the following manners. ? Students' feedback information on teaching learning is analyzed in the departmental committee and shortcomings, if any, are considered and remedial measures for weaknesses are envisaged. ? Teachers' feedback relating to better research and infrastructural facilities are addressed by the policy making bodies like the Board of Research Studies, Development Committee, Sports Committee, Executive Council etc. ? Parents' suggestions regarding the improvement of teaching learning and infrastructural facilities of the students are seriously taken into account by the respective departments and other policymaking bodies of the university. ? The analyzed feedback of the officers and employees are regularly discussed in different administrative departments as well as policymaking bodies and then appropriate measures are taken. ? The analyzed responses of the members of the Alumni Association on teaching learning, admission process, infrastructural development etc. are also taken care of and their help is sought in some cases (such as, teaching learning) for all round development.

The mentoring system for the students functions in the following manner: ? Tutorial classes are held regularly, as reflected in the departmental class routine, to mentor students divided in small groups where one teacher is assigned with the task of mentoring one group. Writing skills for different examinations are developed in these classes. ? The faculties of the departments take special personal care of all the students, including the research scholars, not only for their academic development but also for developing their all round personality. Counselling of the students at personal level is also conducted beyond class hours. ? Job orientation is provided to students by some departments, especially in the field of development of communication skills. The students are regularly motivated to participate in different competitive examination as well as in campus recruitment programmes.? The students are also motivated by the departments to pursue higher studies and to enrol in M.Phil. and Ph.D. Programmes. ? The Dean of Students 'Welfare regularly arranges various cultural and sports competitions to identify the sports and cultural talent of the students, and then motivates them to enhance their skills by organizing different workshops and training programmes. ? The Stress Management Centre aims to help students to reach their highest academic and personal potential. This primarily involves helping students to solve their personal and careerrelated concerns and thereby encouraging their holistic wellness and equipping them with tools towards success. The Centre provides a comfortable atmosphere in which students can discuss any doubts or concerns that might be troubling them. Utmost confidentiality is maintained so that the students can work through their issues and develop the selfawareness to overcome them. Free oneonone counselling services are provided to the students by the Centre. Mental healthrelated awareness/orientation sessions are conducted regularly to sensitize the teaching and nonteaching staff and to increase the awareness in students and thus optimize the Centre's benefits for them

The University has maintenance committee that oversees the maintenance of buildings, classrooms and laboratories. • The maintenance committee is headed by the Registrar who in turn monitors the work of the Supervisor at the next level. The Supervisor is accountable to the Registrar and functions as the coordinator who efficiently organizes the workforce, maintaining duty files containing details about their individual floor wise responsibilities, timings, leave etc. The maintenance officer conducts periodic checks to ensure the efficiency / working conditions of the infrastructure. • Adequate inhouse staff is employed to meticulously maintain hygiene, cleanliness and infrastructure on the campus so as to provide a congenial learning environment. Classrooms, Staffrooms, Seminar halls and Laboratories, etc are cleaned and maintained regularly by Non teaching staff assigned for each floor. Wash rooms and rest rooms are well maintained. Dustbins are placed in every floor. The Green Cover of the campus is well maintained by a full time gardener. • Optimum working condition of all properties/ equipments on the campus is ensured through annual maintenance contracts (AMC). The AMC purview includes maintenance of Generator, Air Conditioners, CCTV cameras and Water Purifiers. Apart from contract workers, the University has trained inhouse electricians and plumbers. • Central Library is maintained by trained Technician and Staff. In some of the cases maintenance is done through AMC also. • Laboratory Technicians /

Assistants/Attendants function under the supervision of heads of the sections /departments for maintenance and best uses of instruments. Instruments at USIC are maintained through AMC under the supervision of Technical Officer. • Facilities for parking and security of the campus are efficiently maintained by University appointed external agency. • Sports Complex, Gymnasia (for male and female), Indoor Stadium, Yoga Centre are maintained through external agencies supervised by the University Sports Officer who functions under Dean of Students' Welfare. • Every department maintains a stock register for the available equipment. • Proper inspection is done and verification of stock takes place at the end of every year. • The civil and electrical works are adequately monitored and maintained by the Engineering office. • Periodic reporting on requirements of repairs and maintenance are submitted by the HODs to the Administrative office. The requirements are collectively processed at the end of every semester so as to keep things ready for the new semester. • Pest control of library books and records is done every year by University appointed external agency. University Engineer and his team are involved in the maintenance of infrastructure facilities. This team looks after the regular maintenance of civil works such as furniture repairs, masonry and plaster works, painting, carpentry, plumbing and house keeping. • The nonteaching staff is also trained in maintenance of science and computer equipment. • The Engineering office workers look after the maintenance of rest rooms, approach roads and neatness of the entire premises. CRITERION VI – GOVERNANCE, LEADERSHIP AND MANAGEMENT

6.1 – Institutional Vision and Leadership

6.1.1 – Mention two practices of decentralization and participative management during the last year (maximum 500 words)

The University firmly believes in the ideal of decentralisation and participative management. Let us take one example. Recently, it has successfully launched LMS i.e. Leave Management System for all the employees faculties, officers and Non-Teaching Staff. All the members of the University are now applying for leaves through the Leave Management System. It is a system, through which the members can apply for leaves and keep track of his/her leave accounts immediately. Thus, the LMS has become a tool for decentralisation, which provides each member of the staff - faculty, officers and non-teaching staff - with enough space for autonomy. On the other hand, it has lightened the burden of particular departments which were erstwhile entrusted with the responsibility of keeping all the records in paper. The new system of LMS is absolutely digital and paper-free, therefore, helps conserving nature (trees and plants used for making papers). Before introducing the new system (i.e. LMS), our Hon'ble Vice- Chancellor invited all the members of the staff for the discussion to the Auditorium to discuss about the pros and cons of the system and to seek opinion of all. After his introductory speech, an open and free discussion took place. Many members raised various questions and their points of view concerning to the system. The university administration took note of all the valid points/suggestions and after taking everything into consideration, the system was customised to cater the special needs of an academic institution for higher learning. After about a month, when the members of the university staff started using the system and were facing some problem of adjustment with the new system, separate meetings for faculties, officers and office staff were convened to take into account the 'teething problems' of the new system. After this thorough exercise, the LMS was further fine-tuned to suit the needs of the staff as far as possible. This salutary initiative stands for many things. First, it ensures the decentralisation of sanctioning leaves, which was erstwhile maintained in a centralised manner (by Registrar or Vice Chancellor), which is now dealt with by sectional/departmental heads. Second, it ensures transparency. Third, it ensures a bold step towards modernisation. Fourth, it was done in a manner which allowed everyone to vent out his/her views while initiating the LMS, which again ensure participation of the staff in a crucial decision of policy-making of the university. And also the employees themselves now can modify their leave account through online system. It is indeed a very apt initiative taken by the Hon'ble Vice-Chancellor, which has become an exemplary experiment towards decentralisation and participative

management.

Best Practices - I 1. Title of the Practice Automated Weather station (AWS) 2. Objectives of the Practice: ? The data generated here benefits the local people. ? This data is useful for the Farmers, Agriculturists, and Horticultural Specialists Apiarists. ? It records weather recorded data like Temperature, Relative Humidity, Atmospheric Pressure, Rainfall, Wind Speed, and Wind Direction Solar Radiation. ? The data is useful for the researchers of our University as well as other universities. ? The data is also useful for beekeeping. 3. The Context ? AWS records the continuous real time weather information of the area. ? The local people as well as farmers are benefited from the data. ? The people were not aware of such information before this AWS installation. ? As the area is dry and is also threatened by drought-like condition due to vagaries of nature the data is extremely beneficial to local people for them to plan sustainable ways to negotiate extreme conditions. ? The data is available to all the people. 4. The Practice ? An Automatic Weather Station (AWS) is defined as a facility that automatically transmits or records observations obtained from measuring instruments. ? A data logger and our university data hub is already linked to the station for the weather data which is automatically logged. ? Comprehensive statistics can be automatically calculated and analyzed from the available data. ? Impressive visual graphics can be displayed ? Detailed data is available like the complete pattern of wind speed direction throughout the day which can be logged. ? In an AWS, the measurements of meteorological elements are converted into electrical signals through sensors. ? The signals are then processed and transformed into meteorological data. The resulting information is finally transmitted by wire or radio or automatically stored on a recording medium. ? This kind of real time as well as point data were not available before. This data will be used by our scholars for further research. ? This work has started on real time data and the forecasting of the weather will be done after some time. This is the constraint and limitation of the data. 5. Evidence of Success • The local newspapers are using the data regularly. • The farmers are also benefited from the data which is provided by our university through local newspapers. 6. Problems Encountered and Resources Required ? Only problem we face regarding the practice is the connectivity hazards of the mobile network system because the data transfer is transmitted through it. 7. Notes (Optional) ? It can be relevant for other institutions. This kind of practices can be done globally which will benefit the society and environment at low cost. Best Practices - II 1. Title of the Practice: Financial management through online transaction. 2. Objectives of the Practice User institutions enjoy many advantages as well. For

The Context Online mode is used by the University for affording credit to a large number of beneficiaries having accounts with bank branches at various locations within the jurisdiction of an ECS Centre by raising a single debit to the bank account of the user institution. ECS Debit is used by the University for raising debits to a large number of accounts maintained with bank branches at various locations within the jurisdiction of a ECS Centre for single credit to the bank account of the user institution. ECS Debit is useful for payment of telephone / electricity / water bills, cess / tax collections, loan instalment repayments, insurance premium etc., that are periodic or repetitive in nature and payable to the user institution by large number of customers etc. ECS is an electronic mode of payment / receipt for transactions that are repetitive and periodic in nature. ECS is used by University for making bulk payment of amounts towards party/ vendor in connection with all recurring and non-recurring expenditures, salary, pension, etc., or for bulk collection of amounts towards various fees from the students of the University and affiliated colleges of the University. Essentially, ECS facilitates bulk transfer of finances from one bank account to many bank accounts or vice versa. 4. The Practice The University collects the bank account particulars prior to participation in the online payment mode. The beneficiary account holders are required to give mandates to the university in the prescribed mandate format of the University to enable them to afford credit to their bank accounts through the online mode mechanism. After getting the duly filled in mandate form from the vendors, the university prepares a payment advice sheet where the bank details of all beneficiaries are mentioned. And the university submits the same to the Bank for payment to the vendors. The Bank pays the same through ECS mode. 5. Our University is located in Maoist affected area in Junglemahal. This area is dominated by tribal people, where a large number of students are 1st generation learners. Vidyasagar University is trying to rehabilitate people affected by Maoist activism without altering their social and cultural life worlds. • The

Department of English, for example, has formed a platform under the aegis of the UGC sponsored SAP, DRS II project, to document, conserve and showcase the languages and cultural texts of the destitute indigenous populations of the area. It has not only created a significant digital archive called Janalipi to disseminate and popularize the distinctive nuances of the languages and cultures of the tribal people, but has also initiated a collaborative process to hone the skills of the tribal artistes and promote the marketability and dissemination of their articles. • Departments of Anthropology, Sociology, History, Santali, Economics and Political Science have collaborated on an interdisciplinary interface to begin a full-fledged research programme in Tribal Studies in the varsity. The interdisciplinary project thrives on a stateof-the-art tribal museum housed in the campus. Researchers on ethnomusicology and ethnology from the country and abroad visit the museum regularly for knowledge resources on the indigenous population of the country. • The university is focused on interdisciplinary, collaborative and community-based research which will help to generate excellent technologies responding to the needs of local, national and global interests. We inspire young students of the University to think more deeply about sustainable use of natural resources. • Vidyasagar University has launched different add on courses and CCAE courses to motivate people on bee keeping, mushroom production, wildlife and hospitality management etc. The eco-friendly campus of this varsity stresses on a teachinglearning environment based primarily on the principles of intimacy between Nature and man. • The meteorological park set up in the university acts as a unique Centre for lending weather related data to local farmers, agriculturists and oceanographic researchers. • The departments of Chemistry and Botany have started developing beverages like jam, jelly and honey in natural processes. • Bee hives are maintained and reared in the campus to support the departmental projects and facilitate the growth of an artificial apiary hub. The products are sold in a small scale for the benefit of the local people. • The students and researchers of the departments also gain hands on experience in the preparation of bio-compatible, wholesome marketable products. • The cashew nut trees in the campus are leased out for generation of financial resources. • The rich flora of the campus promotes pollination and bio-diversity. • The departments of Commerce and Management run an effective entrepreneurship programme for the benefit of students of poor and destitute families.
