Information generated at various sections of the administrative departments including finance is sent to the upper levels of the administration and also to the external agencies as and when required. For example, leave applications of the teachers and employees originating at different departments are sent by the departmental Heads to the Registrar's office for sanction and maintaining the records. Officers' leave applications are routed through the Office of the Vice-Chancellor. Similarly, all finance related records are maintained in the Finance department and information regarding all inflows and outflows of funds are disseminated to the respective internal and external agencies like State Govt., State Higher Education Dept., UGC, etc.

(2). Student admission

Students' admission applications are collected at the office of the Secretary, Faculty Councils for Post Graduate Studies; these are then scrutinized by the respective academic departments. Students are admitted through admission tests followed by counseling sessions. Under Graduate students' admission is decentralized and after admission aggregate data are sent to the University (to the Secretary, Faculty Council for Under Graduate Studies).

(3). Student records

Records are maintained at the office of the Secretary, Faculty Councils for Post Graduate Studies; any report based on the data so generated is sent to the respective higher authorities internally and to the Govt., UGC, etc. externally. Similarly, records of under-graduate students are maintained at the office of the Secretary, Faculty Councils for Under-Graduate Studies.

(4). Evaluation and examination procedures

Evaluation of Under Graduate Examinations is conducted under the supervision of Deputy Controller of Examinations. Examinations are conducted at some selected College-Centres avoiding home-centre. For Evaluation, examination-scripts for General Course examinations are distributed amongst the examiners recommended by the respective Boards of Studies. Spot evaluation is conducted at the University premises under the supervision of Deputy Controller of Examinations. Activities related to Tabulation and result preparation are mainly

outsourced. Records of examination results as approved by the Executive Council are maintained at the office of the Deputy Controller of Examinations.

(5). Research administration

Research is conducted through Projects and Ph. D. programmes. Projects are funded by external agencies like UGC, ICSSR, Govt. of West Bengal, DST, etc. Selection for admission to the Ph. D. Programmes is through entrance test and interview conducted by the respective post-graduate departments through the Ph. D. Committee. Admission is completed after successful completion of Course Work and Pre-registration seminar presentation. The entire process is governed by a Ph. D. Cell under the control and supervision of the Registrar. Overall supervision of the Ph. D. programmes rests with the Board of Research Studies of the University.

(ii) The Library is using SOUL software (Software for University Libraries) for housekeeping jobs in different sections viz. Processing, Periodicals, Readers' services (Circulation), Online Public Access catalogue, etc.
(iii) The Library catalogue can be accessed online. The entire collection of University Library can be searched through OPAC of VU Central Library or through web-OPAC from inside and outside the University campus.
(iv) Library provides specialized services to the Faculties, Research Scholars, and Students.
(v) All the areas of the Central Library are wi-fi enabled to provide wireless access to the internet.
(vi) The Central Library provides web-based access to over 5000 full-text journals and 12 databases 24x7 on institute wide network.
(vii) Library has installed one Network Printer in the CDRS Lab with automatic quota management software for use by the registered members to print their document against payment.
(viii) Computer Centre of the University is maintaining the Campus wide LAN (Optical Fiber based CBIC with 850 nodes throughout the campus.
