(25) Kms radial distance from his/her place of posting are not eligible for allotment of University quarter/hostel". The Executive Council noted further that based on the aforesaid proposal regarding amendment of such provision of the point of the Revised Rules & Regulations for Allotment of the University Quarter/Hostel, the Hon'ble Vice-Chancellor has approved the said amendment on 10.06.2022 for implementation.

Excellence Award - 2018 conferred to Vidyasagar University by Zee 24 News Channel on 21.06.2018 from the then Vice-Chancellor, Professor Ranjan Chakrabarti as the same are kept with him till date, Shri Koushik Paul, Secretary to the Vice-Chancellor was asked to submit his written opinion for not intimating the aforesaid matter to the University authority at the same time when he was carrying on 06.07.2021 such a prestigious award specially which is meant for the University, although he knew the fact and accordingly he was communicated the decision of the EC in this regard vide our letter bearing No. VU/R/9RC-13/C0264/2022 dated 17.06.2022. The Executive Council also noted that in reply to that Shri Paul has submitted a letter bearing No. VC/SECY/06/2022 dated 23.06.2022 regarding his opinion for this purpose and he opined/explained that Professor Ranjan Chakrabarti, former Vice-Chancellor of Vidyasagar University on 06.07.2022 in the early morning called Shri Supriya Panda, one of his office staff through Shri Sital Chandra Mandal and asked for the Plaque and the Memento conferred on Vidyasagar University by the Zee-24 News Channel and they handed over with same to Professor Chakrabarti in the Vice-Chancellor's Bungalow who took those things away with him. Inadvertently he forgot to inform the incident to the University authority at that moment for which he seeks an unconditional apology and he assured that this type of omission will not be repeated in future.

After thorough discussion on the letter submitted by Shri Koushik Paul, Secretary to the Vice-Chancellor of Vidyasagar University regarding his opinion for not intimating the matter regarding carrying of the Plaque and the Memento of Education Excellence Award - 2018 conferred to Vidyasagar University by the Zee 24 News Channel, by the then Hon'ble Vice-Chancellor of Vidyasagar University to the University at the time when he was carrying the same, it was resolved that the opinion/explanation of Shri Paul in the matter be accepted and Shri Paul be requested not to issue/hand over such a valuable and prestigious materials of the University to anybody in near future without the information and/or prior approval of the University authority henceforth. Resolved further that the Registrar be requested to communicate the same to be incumbent concerned in this regard.

After thorough discussion on the letter submitted by Shri Supriya Kumar Panda, Group – D (Contractual) and engaged in the office of the Vice-Chancellor of Vidyasagar University regarding his opinion for not intimating the matter regarding carrying of the Plaque and the Memento of Education Excellence Award - 2018 conferred to Vidyasagar University by the Zee 24 News Channel, by the then Hon'ble Vice-Chancellor of Vidyasagar University to the University at the time when he was carrying the same, it was resolved that the opinion/explanation of Shri Panda in the matter be accepted and Shri Panda be requested not to issue/hand over such a valuable and prestigious materials of the University to anybody in near future without the information and/or prior approval of the University authority henceforth. Resolved further that the Registrar be requested to communicate the same to be incumbent concerned in this regard.

- 05(g) To place before the Executive Council of Vidyasagar University, the Memorandum bearing No. 6284-F(Y) dated 28.09.2018 issued by the Additional Chief Secretary to the Government of West Bengal, Finance Department, Audit Branch regarding guidelines for Deduction and Deposit of TDS on GST by the DDO/Operators or Administrators of Deposit Accounts.

**Resolution:** The Executive Council of Vidyasagar University noted the Memorandum bearing No. 6284-F(Y) dated 28.09.2018 issued by the Additional Chief Secretary to the Government of West Bengal, Finance Department, Audit Branch regarding guidelines for Deduction and Deposit of TDS on GST by the DDO/Operators or Administrators of Deposit Accounts. The Executive Council noted also that from 01.01.2018 all the Deductors viz. DDOs and Operators/Administrators of LF/PL/Deposit Accounts (Other than PF Deposits) will have to deduct TDS on GST while making payment to the supplier (Deductee) of taxable goods or services or both, where the total value of such supply, under a contract, exceeds two lakh and fifty thousand rupees & date of Tax Invoice is on or after 01.10.2018. The tax amount so deducted shall have to be deposited to the Government Exchequer. For payment process of Tax Deduction at source under GST, DDO may deduct as well as deposit the GST TDS for each bill/invoice individually by generating CPIN following some process specified therein.

After thorough discussion on the memorandum issued by the Additional Chief Secretary to the Government of West Bengal, Finance Department, Audit Branch regarding guidelines for Deduction and Deposit of TDS on GST by the DDO/Operators or Administrators of Deposit Accounts, it was resolved that the said Memorandum of the Finance Department, Audit Branch, Government of West Bengal be accepted and implemented in this University. Resolved further that the Finance Officer of this University be requested to process further regarding this as advised by the Finance Department, Audit Branch, Government of West Bengal.

After thorough discussion on the matter regarding using the e-mail Id: "vcvu.confidential@gmail.com" created by the University for urgent and confidential communications with the Hon'ble Vice-Chancellor of Vidyasagar University, it was resolved that the Google be requested to reset the password of the said e-mail ID and the Registrar of this University be requested to process further in this regard.

- 05(i) To place before the Executive Council of Vidyasagar University, the Articles of Charge framed against Shri Abhijit Ghose, Assistant Director (purely on contract basis), Centre for Distance and Online Education (Erstwhile Directorate of Distance Education (DDE) of Vidyasagar University.

After thorough discussion on the Articles of Charge framed against Shri Abhijit Ghose, Assistant Director (purely on contract basis), Centre for Distance and Online Education (Erstwhile Directorate of Distance Education (DDE) of Vidyasagar University pertaining to anomalies of management of Aranyak Guest House and inconsistencies in PG Part-I SLMs printing & other related issues of the CDOE, it was resolved that the said articles of charge as framed against Shri Ghose be accepted and the Registrar be requested to issue the articles of charge against Shri Ghose for this purpose.

University through CMO/CMRO portal against the University authority without the information and prior approval of the University duly forwarded by the office of the District Magistrate, Paschim Medinipur and the Assistant Secretary to the Higher Education Department, Government of West Bengal.

After thorough discussion on the letter received from Shri Prabir Das, Driver of Vidyasagar University regarding the complaint lodged by him in the CMRO Portal against the University authority without the information and prior approval of the University, it was resolved that the content of the letter submitted by Shri Das be condemned and the reply regarding lodging the complaints against the University authority as he did not get the proper justice from the University he was bound to lodge the complaint to Her Excellence the Chief Minister of West Bengal for justice made by Shri Das is dissatisfactory. Resolved also that the disciplinary action be initiated against Shri Das as per the norms of the University for dereliction of duty, insubordination and unbecoming of an employee as all the grievances lodged by Shri Das against the University authority are false, baseless, concocted with malicious intention and ulterior motive to malign the image of the University and its administration. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

- 05(k) To place before the Executive Council of Vidyasagar University, the letter dated 27.06.2022 received from Shri Prabir Das, Driver of Vidyasagar University regarding vacant of the Unit of the Bankim Chandra Abasan of this University allotted to him and hand over the said vacant possession to the University.

After thorough discussion on the received from Shri Prabir Das, Driver of Vidyasagar University regarding vacant of the Unit of the Bankim Chandra Abasan of this University allotted to him and hand over the said vacant possession to the University, it was resolved that the reply regarding filling a Writ Petition bearing WPA No. 11804 of 2022 before the Hon'ble High Court, Calcutta for getting proper justice as he did not get the proper justice from the University made by Shri Das is dissatisfactory. Resolved also that the disciplinary action be initiated against Shri Das as per the norms of the University for insubordination and unbecoming of an employee etc. Resolved further the Registrar and the Establishment Section of this University be requested to process further in this regard.

- 05(l) To place before the Executive Council of Vidyasagar University, the letter dated 23.06.2022 received from Professor Ranjan Chakrabarti, former Vice-Chancellor of Vidyasagar University regarding the whereabouts of the plaque and the memento of the Education Award – 2018 conferred upon to Vidyasagar University by the Zee-24 News Channel.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 23.06.2022 received from Professor Ranjan Chakrabarti, former Vice-Chancellor of Vidyasagar University regarding the whereabouts of the plaque and the memento of the Education Award - 2018 in reply to the letter No. VU/R/9EC-13/C0253/2022 dated 15.06.2022 issued by the University to Professor Chakrabarti based on the decision taken by the Ninth Executive Council of Vidyasagar University in its Thirteenth (13th) meeting held on 09.06.2022 on the basis of the letter submitted by the Secretary to the Vice-Chancellor of Vidyasagar University regarding taking away the Plaque and the Memento of the Education Excellence Award - 2018 which was conferred on Vidyasagar University by the Zee-24 News Channel on 21.06.2018 by the former Vice-Chancellor of Vidyasagar University, Professor Ranjan Chakrabarti on 06.07.2021 after completion of his tenure as Vice-Chancellor. The Executive Council noted further from the letter dated 10.06.2022 received from Shri Piglu Behera, a contractual employee of CDOE (erstwhile DDE) Vidyasagar University and engaged at the residence of Professor Chakrabarti stating that on 6th July, 2021 morning he moved with Professor Chakrabarti from the University campus to go to his residence (Flat) at Kamalgaji and Professor Chakrabarti was accompanied by the Education Excellence Award - 2018 conferred by Zee-24-Ghanta. Shri Behera also stated that the said Award was kept in the office room of his Kamalgaji's Flat at Kolkata and he stayed at the Flat of Professor Chakrabarti from 06.07.2021 to 14.07.2021.
