



It is obligatory and mandatory for every Centre of Legal Education (University, Law Colleges etc.) to follow the Legal Education Rules 2008 meticulously.

After thorough discussion on the received from the Secretary, Bar Council of India, New Delhi pertaining to compliance of all the Rules of Legal Education 2008 by all Centres of Legal Education failing which approval of affiliation and/or recognition shall not be renewed/granted from the academic session 2020-2021 onwards, it was resolved that the said Rules of Legal Education - 2008 be followed by the Law colleges under Vidyasagar University as the said rules are mandatory for all legal education stipulated by the Bar Council of India, New Delhi. Resolved further that the Inspector of Colleges of this University be requested to communicate the same to all law colleges under Vidyasagar University specifying strictly adhere to the said Legal Education Rules - 2008.

- 06(n) To consider the letter dated 17.02.2020 submitted by Ms. Shampa Maity, Senior Peon of Vidyasagar University praying for recovery of fourteen (14) days half-pay medical leave amount from her salary as she enjoyed fourteen days full-pay medical leave in place of half-pay medical leave as per norms.
- Resolution:** The Executive Council of Vidyasagar University noted that Ms. Shampa Maity, Senior Peon of Vidyasagar University at present working in the office of the Inspector of Colleges of this University praying for

recovery of fourteen (14) days half-pay medical leave amount from her salary as she enjoyed fourteen days full-pay medical leave in place of half pay medical leave. The Executive Council noted further that as per leave rules of Vidyasagar University, an employee may enjoy 180 days full pay medical leave during his service period but Ms. Maity enjoyed total 201 days leave on medical ground. Now she has prayed that out of total 201 days, 180 days to be counted as full-pay medical leave, 07 days as Earned Leave on medical ground and rest 14 days as half-pay medical leave.

After thorough discussion on the letter submitted by Ms. Shampa Maity, Senior Peon of Vidyasagar University praying for recovery of fourteen (14) days half-pay medical leave amount from her salary as she enjoyed fourteen days full-pay medical leave in place of half-pay medical leave as per norms, it was resolved that fourteen (14) days half-pay medical leave amount be recovered from the salary of Ms. Shampa Maity, Senior Peon of Vidyasagar University as prayed for by Ms. Maity with prior information to the incumbent concerned. Resolved further that the Finance Officer and the Establishment Section of this University be requested to process further in this regard.

- 06(o) To discuss the matter regarding exploration of possibility of revision of pay of teachers, officers and other employees engaged in Vidyasagar University in contractual manner.

**Resolution:** After thorough discussion on the matter regarding exploration of possibility of revision of pay of teachers, officers and other employees engaged in Vidyasagar University purely on contractual manner based on the recent revision of pay scale of University teachers, officers and employees under ROPA-2019, it was resolved that a Committee consisting of (a) the Registrar, (b) the Audit Officer, (c) Dr. Asim Kumar Bera, Principal, Mahishadal Raj College and the Finance Officer (Convener) be constituted to look into the matter and to suggest the revision of existing pay of contractual teachers, officers and other employees of this University.

- 06(p) To consider the letter dated 05.03.2020 submitted by the Head of the Department of Business Administration through mail regarding requirement of faculty in the MBA Department of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 05.03.2020 submitted by the Head of the Department of Business Administration through mail stating that at present there are only three number of faculties in the MBA Department. Presently the Department is running various courses, like, MBA, BBA, ED Course, Ph.D. in Management etc. In this connection he has requested that atleast two more faculty are urgently required in the said department for smooth functioning of such courses. The Executive Council also noted that Dr. Tarak Nath Sahu and Dr. Abhijit Sinha of the Department of Commerce of this University may be considered as faculty of the said department on permanent basis as suggested by the Head of the department concerned in its aforesaid letter.

After thorough discussion on the letter submitted by the Head of the Department of Business Administration through mail regarding requirement of faculty in the MBA Department of Vidyasagar University, it was resolved that the service of Dr. Tarak Nath Sahu as faculty of commerce be transferred from the Department of Commerce to the Department of Business Administration purely on deputation basis for a period of one year or until further order whichever is earlier with immediate effect.



06(q) To place before the Executive Council of Vidyasagar University, the letter bearing No. 232(22)-Edn(U)/EH/1U-59/19 dated 28.02.2020 received from the Principal Secretary to the Government of West Bengal, Higher Education Department, University Branch regarding modified revision of pay structure of Officers (other than Registrar, Controller of Examinations, Inspector of Colleges and Finance Officer) of the State-aided Universities of West Bengal.



The Executive Council also noted that the SERB is also approved for payment of Rs.5,25,000/- (Rupees Five Lakh Twenty Five Thousand) only under grants for creation of capital assets and Rs.12,83,000/- (Rupees Twelve Lakh Eighty Three Thousand) only under Grants-in-aid General in favour of Vidyasagar University as first installment of the grant for the year 2019-2020 for implementation of the said project.
