*After thorough discussion on the observations on the report of One-man Enquiry Committee constituted regarding registration of Ms. Selina Khatun and Ms. Baisali Guha in the Ph.D. Programme – 2015 of the Department of History of Vidyasagar University which was accepted by EC earlier, submitted by Dr. Ujjayan Bhattacharya, Professor, Department of History and Secretary, Ph.D. Committee of the said Department, it was resolved that the observations made by Professor Bhattacharya on the report of the One-man Enquiry Committee is dissatisfactory. Resolved also that a warning/censure letter be issued to Professor Bhattacharyya advising him not to repeat such practice in near future and it should be recorded in his Service Book.
