**Resolution :** *The Executive Council of Vidyasagar University noted the letter dated 15.02.2017 submitted by Shri Tapas Kumar Rout, Security Guard of Vidyasagar University along with the certified copy of the judgement passed by the Hon'ble Additional Session Judge, F.T.C. 2nd, Paschim Medinipur stating that a case was filed against him under sections 376/506 of Indian Penal Code before the Hon'ble Additional District & Sessions Judge, Fast Track 2nd Court, Paschim Medinipur bearing Sessions Trial No. 27-02-16 and Her Lordship has passed an order on that case on 30.01.2017 wherein Shri Tapas Kumar Rout was acquitted U/s. 235(1) of Cr. PC as he is found not guilty for commission of offence U/s. 376/506 IPC. In this connection he has requested to permit him to join his regular duty at Vidyasagar University. The Executive Council also noted the detailed note prepared by the Establishment Section of the office of the Registrar in favour of Shri Rout and from the above note it has been observed that Shri Rout concealed his arrest & did not inform the University and Shri Rout gave false information to the University.*

*After thorough discussion on the letter submitted by Shri Tapas Kumar Rout, Security Guard of Vidyasagar University pertaining to permission for joining his regular duty at Vidyasagar University and careful consideration of the judgement passed by the Hon'ble Additional District & Sessions Judge, Fast Track 2<sup>nd</sup> Court, Paschim Medinipur regarding his acquaintance for commission of offence and also the note prepared by the Establishment Section regarding the false statement made by him in this regard, it was resolved that a One-man Enquiry Committee be constituted to enquire the whole matter and to submit a report in this regard for further consideration of the EC. Resolved also that regarding nomination of the one-man enquiry committee, the matter be left to the Hon'ble Vice-Chancellor for necessary action.*



Resolved further that the pension and all other benefits of Shri Swapan Kumar Bose be kept on hold till finalization of the enquiry proceedings. Resolved again that regarding nomination of one-man enquiry committee, the matter be left to the Hon'ble Vice-Chancellor for necessary action.*

- 06(u) To place before the Executive Council of Vidyasagar University, the letter bearing No. SGPM/Statute/01/17 dated 17.03.2017 received from the Convener, Sammilita Granthagar Peshajibi Mancha, Kolkata pertaining to modification of status and service conditions of Librarian for amendment in the University Statute.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. SGPM/Statute/01/17 dated 17.03.2017 received from the Convener, Sammilita Granthagar Peshajibi Mancha, Kolkata intending for amendment the issues regarding teaching status, leave rules, retirement age, allotment of classes of Librarians, Assistant Librarians/Deputy Librarians serving in the government/government-aided colleges and Universities in West Bengal in the Statute of Vidyasagar University.*



- 06(v) To consider the letter bearing No. BIBS/248/16-18/R/EX dated NIL received from the Principal, Bengal Institute of Business Studies(BIBS), Kolkata pertaining to permission for the students who have secured less than 45% marks in graduation for admission into the 2-year regular M.B.A. course.

Resolution: The Executive Council of Vidyasagar University noted the letter bearing No. BIBS/248/16-18/R/EX dated NIL received from the Principal, Bengal Institute of Business Studies(BIBS), Kolkata stating that at the present moment the candidature of forty four(44) nos. of student are on hold since they have less than the requisite percentage in graduation but have passed from different universities. The Executive Council also noted that many students are depriving to avail job oriented courses within the state because of the stipulation on qualifying percentage. In this connection, the Principal has requested the University to consider these students and allow them to pursue the said course under Vidyasagar University and help them to shape up their future.

After careful consideration of the letter received from the Principal, Bengal Institute of Business Studies(BIBS), Kolkata pertaining to permission for the students who have secured less than 45% marks in graduation for admission into the 2-year regular M.B.A. course, it was resolved that decided that the forty four (44) number of students who have secured less than 45% of marks aggregate in graduation and those candidatures are on hold be permitted for admission at Bengal Institute of Business Studies, Kolkata for conducting 2-Year regular Course of Vidyasagar University as a special case provided that the concerned college authority shall have to submit an undertaking stating that such practice should not be continued in future.

- 06(w) To consider the letter dated 17.03.2017 submitted by Dr. Mukul Kanti Gole, Secretary, Council for Undergraduate Studies of Vidyasagar University pertaining to counting his date of joining at Vidyasagar University with effect from 05.02.2014 in place of 06.02.2014.

Resolution: The Executive Council of Vidyasagar University noted the letter dated 17.03.2017 submitted by Dr. Mukul Kanti Gole, Secretary, Council for Undergraduate Studies stating that he joined this University as Secretary, Council for Undergraduate Studies of this University on 06.02.2014. He released from his previous employer, A.C. College, Jalpaiguri with effect from 04.02.2014 for joining at Vidyasagar University but due to holiday of the University on 05.04.2014 on account of Saraswati Puja, he could not join on that day and accordingly he joined this University on 06.02.2014. In connection with the above for continuation of his past services from A.C. College, Jalpaiguri, he has requested to consider his date of joining on 05.02.2014 in place of 06.02.2014.

After careful consideration of the letter submitted by Dr. Mukul Kanti Gole, Secretary, Council for Undergraduate Studies of Vidyasagar University pertaining to counting his date of joining at Vidyasagar University with effect from 05.02.2014 in place of 06.02.2014, it was resolved that the date of joining of Dr. Gole in the post of Secretary, Council for Undergraduate Studies of Vidyasagar University be counted with effect from 05.02.2014 condoning the date of joining on 6th February, 2014.



- 06(x) To place before the Executive Council of Vidyasagar University, the note prepared and submitted by the office of the Registrar pertaining to continuation of temporary services of the persons appointed in Women's Studies Centre of Vidyasagar University for a further period of two months after the expiry of the UGC XIIth plan period (31.03.2017) and also disbursement of salary to them from the University fund.

Resolution: *The Executive Council of Vidyasagar University noted the note prepared and submitted by the office of the Registrar pertaining to continuation of temporary services of the persons appointed in Women's Studies Centre of Vidyasagar University for a further period of two months after the expiry of the UGC XIIth plan period (31.03.2017) due to non-receiving of concurrence from the Higher Education Department, Government of West Bengal and also disbursement of salary to them from the University fund.*

*After thorough discussion on the note prepared and submitted by the office of the Registrar pertaining to continuation of temporary services of the persons appointed in Women's Studies Centre of Vidyasagar University for a further period of two months after the expiry of the UGC XIIth plan period (31.03.2017) and also disbursement of salary to them from the University fund, it was resolved that the matter be brought to the notice of the Higher Education Department, Government of West Bengal requesting for early concurrence on those posts of the Womens' Studies Centre for continuation in this University or seeking their advice/opinion for release the fund from the University fund for continuation of such posts in this University.*

- 06(y) To place before the Executive Council of Vidyasagar University, the letter bearing F.No. Admn. 1/2014-15 (ERO) dated 10.03.2017 along with a representation made by Shri Vivekananda Maiti, Assistant Professor of Khejuri College received from the Under Secretary, University Grants Commission, New Delhi pertaining to irregularities and misappropriation of funds by the Principal, Head Clerk and Accountant of Khejuri College.

Resolution: *The Executive Council of Vidyasagar University noted the letter bearing F.No. Admn. 1/2014-15 (ERO) dated 10.03.2017 along with a representation made by Shri Vivekananda Maiti, Assistant Professor of Khejuri College regarding irregularities and misappropriation of funds by the Principal, Head Clerk and Accountant of Khejuri College received from the Under Secretary, University Grants Commission, New Delhi requesting to examine the factual position in the matter and take appropriate action against the erring officials of the college.*

*After thorough discussion on the letter received from the Under Secretary, University Grants Commission, New Delhi pertaining to irregularities and misappropriation of funds by the Principal, Head Clerk and Accountant of Khejuri College and careful consideration of the representation attached with the aforesaid letter, it was resolved that a copy of the said letter of UGC along with the representation made by Shri Vivekananda Maiti be sent to the President of the Governing Body of Khejuri College for placing before the Governing Body of the college for necessary action. Resolved also that the decision of the Governing Body of Khejuri College in this regard be placed before the next meeting of the Executive Council for further course of action.*



- 06(z) To place before the Executive Council of Vidyasagar University, the letter bearing No. 7-128/2016-RCI dated 12.2016 received from the Chairperson, Rehabilitation Council of India, New Delhi pertaining to establishment of Centre for Disability Study at University level for facilitating university affiliation to organization/institution desirous to offer RCI approved programmes.

Resolution: The Executive Council of Vidyasagar University noted the letter bearing No. 7-128/2016-RCI dated 12.2016 received from the Chairperson, Rehabilitation Council of India, New Delhi stating that Rehabilitation Council of India is a Statutory body constituted by the Government of India under the Act of Parliament namely Rehabilitation Council of India Act, 1992. It is mandatory as per Section 13 of RCI Act, 1992 for professionals and personnel in Disability Rehabilitation and Special Education to obtain a "Registration Certificate" from the Rehabilitation Council of India to work in the field of disability in India. It has been brought to the notice of the Council that the Institutions/organizations desirous to offer under graduate and above level programmes face difficulty in getting university affiliation to run RCI approved programmes due to non-existence of department in concerned discipline/area or Centre of Disability Studies/Department of Disability Studies at the level of University. In this connection, the Chairperson has requested for establishment of a Centre for Disability Studies at University level which will facilitate university affiliation to organization/institution desirous to offer RCI approved programmes.

After careful consideration of the letter received from the Chairperson, Rehabilitation Council of India, New Delhi pertaining to establishment of Centre for Disability Study at University level for facilitating university affiliation to organization/institution desirous to offer RCI approved programmes, it was resolved that the said proposal of RCI be accepted in principle. Resolved also that the Inspector of Colleges, Secretary, Faculty Councils for Postgraduate Studies and Secretary, Council for Undergraduate Studies of Vidyasagar University be requested to look into the matter and to take further process in this regard.

- 06(z-1) To place before the Executive Council of Vidyasagar University, the letter received through mail dated 15.03.2017 from the Secretary, Bar Council of India pertaining to verification of law degrees without charging any fee in compliance with the order passed by the Hon'ble Supreme Court of India.

Resolution: The Executive Council of Vidyasagar University noted the letter received through mail dated 15.03.2017 from the Secretary, Bar Council of India stating that the Supreme Court of India vide its order dated 01.03.2017 in transferred case (Civil) No(s) 126/2015 (Ajayider Sangawan Vs. Bar Council of Delhi & Others directed the Universities to verify law degrees without charging any fee for the present and completed the exercise of verification of degree within a period of four weeks from the date of request made by the respective State Bar Councils and the Bar Council of India.

After thorough discussion on the letter received from the Secretary, Bar Council of India pertaining to verification of law degrees without charging any fee in compliance with the order passed by the Hon'ble Supreme Court of India, it was resolved that the said verdict of the Hon'ble Supreme Court of India be accepted. Resolved also that the Controller of Examinations, the Finance Officer and transcript section of this University be requested to process further in compliance with the said order.



- 06(z-2) To place before the Executive Council of Vidyasagar University, the letter dated 27.01.2017 submitted by the General Secretary, Vidyasagar University Students' Union pertaining to creation of new office bearers in the Assistant rank of the Students' Union Body of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 27.01.2017 submitted by the General Secretary, Vidyasagar University Students' Union pertaining to creation of new office bearers in the Assistant rank of the Students' Union Body of Vidyasagar University as the number of seats of the said election are so high in comparison with the existing office bearers of the said body.*

*After thorough discussion on the letter submitted by the General Secretary, Vidyasagar University Students' Union pertaining to creation of new office bearers in the Assistant rank of the Students' Union Body of Vidyasagar University, it was resolved that the prayer of the General Secretary in this regard be declined at the moment.*

- 06(z-3) To consider the letter dated 08.02.2017 submitted by Shri Asish Sahu, a daily wage worker in the office of the Controller of Examinations of this University regarding sanctioning of financial help from the University for his treatment purpose.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 08.02.2017 submitted by Shri Asish Sahu, a daily wage worker in the office of the Controller of Examinations of this University praying for sanctioning of financial help for his treatment.*

*After thorough discussion on the letter submitted by Shri Asish Sahu, a daily wage worker in the office of the Controller of Examinations of this University regarding sanctioning of financial help from the University for his treatment purpose, it was resolved that the matter be forwarded to the Finance Officer of Vidyasagar University for his opinion and after getting the opinion from the Finance Officer in this regard, further action will be taken.*

- 06(z-4) To consider the proposal dated 21.03.2017 submitted by the Secretary(Actg.), Faculty Council for Postgraduate Studies of this University pertaining to decreasing the fees of the self-financing postgraduate courses of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the detailed proposal submitted by the Secretary(Actg.), Faculty Council for Postgraduate Studies of this University pertaining to decreasing the fees of the self-financing postgraduate courses of Vidyasagar University based on the demand pressed by the students of Vidyasagar University. The Executive Council also noted the reduction fees proposed by the Secretary, Faculty Council for Postgraduate Studies in this regard.*

*After thorough discussion on the proposal submitted by Secretary(Actg.), Faculty Council for Postgraduate Studies of this University pertaining to decreasing the fees of the self-financing postgraduate courses of Vidyasagar University, it was resolved that the reduction of fees after deduction of 8% proposed by the Secretary be accepted and approved except the self-financing postgraduate courses in Master of Business Administration, Computer Science and Quality Control & Assurance in Microbial Technology. Resolved also that in case of such courses, existing fees will remain valid.*

Resolution: The Executive Council of Vidyasagar University noted the detailed observations on the complaint lodged by Ms. Sutapa Ghosh, Associate Professor in Anthropology, Seva Bharati Mahavidyalaya, Kaptari regarding constant harassment and sexual discrimination by the Teacher-in-Charge of the said college submitted by the Chairperson of Internal Complaint Committee (ICC) of Vidyasagar University. The Executive Council also noted the detailed observations made by the Chairperson of Internal Complaint Committee of Seva Bharati Mahavidyalaya, Kaptari in this regard. The Executive Council further noted the observations made by the Administrator of Seva Bharati Mahavidyalaya, Kaptari in this regard.

After thorough discussion on the observations submitted by the Chairperson of Internal Complaint Committee of Vidyasagar University based on the complaint lodged by Ms. Sutapa Ghosh, Associate Professor in Anthropology, Seva Bharati Mahavidyalaya, Kaptari regarding constant harassment and sexual discrimination by the Teacher-in-Charge of the said college and subsequently the observations made by the Chairperson, Internal Complaint Committee, Seva Bharati Mahavidyalaya and the Administrator of the said college in this regard, it was resolved that all observations made by the Chairperson, ICC, V.U., Chairperson, ICC, Seva Bharati Mahavidyalaya and Administrator of Seva Bharati Mahavidyalaya be accepted. Resolved also that copies of all observations in this regard be forwarded to the Administrator of the said college for placing before the Governing Body of Seva Bharati Mahavidyalaya for necessary action and after getting the decision of the Governing Body in this regard, the matter be placed before the EC for further action. Resolved again that copies of all observations be also forwarded to the Director of Public Instruction, Government of West Bengal for his kind perusal.

06(z-6) To place before the Executive Council of Vidyasagar University, the letter bearing D.O. No. 803/114/2016-CRS dated 05.01.2017 received from the Joint Secretary (Policy & Admn.), Ministry of Information and Broadcasting, Government of India, New Delhi pertaining to setting up Community Radio Station (CRS) in the Vidyasagar University Campus.



**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing D.O. No. 803/114/2016-CRS dated 05.01.2017 received from the Joint Secretary (Policy & Admn.), Ministry of Information and Broadcasting, Government of India, New Delhi stating that the concept of Community Radio Stations (CRS), especially the successful role that this new medium of communication has been playing in the education sector of India. Community Radios are small FM radio stations with a coverage area of around 10-15 KM radius. Ministry of Information and Broadcasting is mandated to grant permissions for setting up Community Radio Stations to non-profit organizations like educational and other institutions/organizations. In this connection he has requested the University to apply for setting up of Community Radio Station in Vidyasagar University campus as per the prescribed guidelines.

After thorough discussion on the letter received from the Joint Secretary (Policy & Admn.), Ministry of Information and Broadcasting, Government of India, New Delhi pertaining to setting up Community Radio Station (CRS) in the Vidyasagar University Campus, it was resolved that the said proposal be accepted gladly. It was also resolved that the Director of Computer Centre of Vidyasagar University be requested to process further in this regard.

06(z-7) To discuss the matter regarding various activities made by Shri Sudarshan Singh, Junior Assistant-cum-Typist of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted different letters issued by the University to Shri Sudarshan Singh, Junior Assistant-cum-Typist of Vidyasagar University and subsequently the reply received from him regarding misbehavior, insubordination and such other activities. The Executive Council also noted that all the replies made by Shri Singh in this regard are dissatisfactory.

After thorough discussion on the matter regarding various activities made by Shri Sudarshan Singh, Junior Assistant-cum-Typist of Vidyasagar University, it was resolved that a charge sheet be issued to Shri Singh as per the norms of the University.


