

Resolved also that the seats of M.B.A. Course for the academic session 2014-2015, which are lying vacant at present consequent upon leaving the course, should be filled-up by the eligible candidates including

*Viva-voce and Group Discussion as per the norms of the University latest by 25th November, 2014. Resolved further that all the fresh admissions will be made together on 25.11.2014. Resolved again that the recommendation of the Committee regarding admission of the candidate mentioned therein be accepted.*


