## NOTIFICATION

In exercise of the power conferred by Sub-Section (2) of section 57 of the Vidyasagar University Act, 1981 (West Bengal Act XVIII of 1981) I, Bhupesh Chandra Mukherjee the First Vice-Chancellor of the Vidyasagar University appointed under sub-section (1) of that section as Vice-Chancellor, hereby cause with the approval of the Chancellor and with the assistance of the Committee consisting of members nominated by the State Government the Vidyasagar University First Regulations, 1985 (hereinafter referred to as the First Regulationa) to be framed as follows:

### THE VIDYASAGAR UNIVERSITY FIRST REGULATIONS

#### CHAPTER-I

#### PRELIMINARY

1. **Short Title:** These Regulations may be called the Vidyasagar University. First Regulations, 1985.
2. **Definition:** In these Regulations, unless there is anything repugnant in the subject or context, –
  - (1) “Academic year” means a period of twelve months commencing on the first day of June;
  - (2) “Chapter” means a Chapter of these Regulations;
  - (3) “Examiner” includes a Convenor, a head examiner, a paper setter and a moderator;
  - (4) “Post-Graduate Studies” means Studies for admission to which the necessary qualification is a Bachelor’s degree or its equivalent;
  - (5) “Section” means a section of the Act;
  - (6) “The Act” means the Vidyasagar University Act, (West Bengal Act XVIII of 1981);
  - (7) “Undergraduate Studies” means which lead to a certificate or degree of the University and are not Post-Graduate Studies; and
  - (8) Words and expressions used but not defined in these Regulations shall have the same meaning as in the Act.

## CHAPTER-II

Power and functions of the Boards of Studies attached to the Faculty Councils for Post-Graduate Studies and the Council for Under-Graduate Studies.

### PART-I

#### Faculty Councils for Post-Graduate Studies

3. The Faculty Councils for Post-Graduate Studies specified in column I of the table below shall comprise the subjects specified in the corresponding entries in column II of the said table.

**6. Functions and Duties of Boards of Studies attached to Faculty Post-Graduate Studies and Council for Under-Graduate Studies**

Subject to provisions of the Act, Statutes and the Ordinances, the functions and duties of a Board of Studies attached to a Council for Post-Graduate Studies or Council for Under-Graduate Studies shall be:

- (a) To advise the relevant Faculty Council or Council for Under-Graduate Studies for making Regulations relating to courses of study, division of subjects and examinations in the subjects with which the Board is concerned, and the conditions for admission to such courses of study and examinations;
- (b) To prescribe text-books for courses of study in the subject or subjects with which the Board is concerned, provided that no text-book shall be so prescribed except on the recommendation in writing by a member of the Board who certified that he has read the

- book and considers it suitable for the purpose;
- (c) to make recommendations to the relevant Faculty Council for Post-Graduate Studies or the Council for under-Graduate Studies regarding the conduct of instructions, teaching, training and/or research in the subject or subjects with which the Board is concerned;
  - (d) to make proposals to the relevant Faculty Council for Post-Graduate Studies regarding the minimum number of teachers needed or other resources facilities necessary to provide proper instruction in the subject or subjects with which the Board is concerned;
  - (e) to make recommendations to the Library Committee in matters involving library policy and procedure and to the Librarian with respect to the acquisition of Library materials which, in its judgement, will improve the capacity of the library in providing service to teachers and students;
  - (f) to recommend to the relevant Faculty Council or the Council for Under-Graduate Studies the names of suitable persons for appointment -
    - i) in the case of Post-Graduate Studies, as members of Boards of Examiners, and
    - ii) in the case of Under-Graduate Studies as Examiners,in the subject of subjects with which the Board is concerned:  
Provided that in cases referred to in Sub-clause (ii), recommendations for appointment as paper-setters or moderators shall be made to the Vice-Chancellor;
  - (g) to consider objections raised to questions set for any examination held by the University in the subject or subjects with which the Board is concerned;
  - (h) to suggest to the relevant Faculty Council for Post-Graduate Studies or the Council for Under-Graduate Studies, after considering the reports of examiners, improvements in the methods of instructions, studies and examinations, in the subject or subjects with which the Board is concerned;
  - (i) to consider and report on any matter referred to it by any authority or body of the University involving instructions or research in the subject or subject or subjects with which the Board is concerned;
  - (j) to bring to the notice of relevant Faculty Council for Post-Graduate Studies which are considered by the Board to be important and are connected with the instructional and examination programme of the University in the subject or subjects with which the Board is concerned;
  - (k) to exercise and perform such other functions and duties as may be conferred and imposed on the Board by or under the Act, the Statutes, the Ordinances and these

Regulations, and;

- (1) to submit to the relevant Faculty Council for Post-Graduate Studies or the Council for Under-Graduate Studies every year its annual report.

## **7. Meetings of Boards of Studies**

- (1) Every Board of Studies attached to a Faculty Council for Post-Graduate Studies or a Council for Under-Graduate Studies shall meet at least thrice in every academic year and oftener when so required by the Chairman. It shall, also, meet on requisition in writing by at least one-third of the total number of its members.
- (2) The Secretary of the Faculty Council for Post-Graduate Studies or the Council for Under-Graduate Studies concerned or such other person, as may be appointed by the Vice-Chancellor in this behalf, shall serve as the Secretary to the board and shall keep record of the Proceeding thereof.
- (3) Meetings of a Board of Studies attached to a Faculty Council for Post Graduate Studies or the Council for Under-Graduate Studies shall be convened by the Secretary on such dates and at such times and places as may be fixed by him. The Secretary shall also convene a meeting of a Board when so requested by its Chairman.
- (4) A joint meeting of two or more Boards of Studies may be convened by the Vice-Chancellor on such date, at such time and place and for transacting such business as he may think fit.

The members of the Boards present shall jointly elect one of their member to act as Chairman, and such of the persons serving as Secretaries of the Boards concerned as may be determined by the Vice-Chancellor shall act as Secretary, at such joint meeting and record of Proceedings thereof shall be kept by such Secretary.

## **CHAPTER-III TEACHERS' COUNCIL**

### **8. Composition of Teachers' Council**

- (1) In every College there shall be a Teachers' Council. All teachers, including the Principal of the College, shall be members of the Council

Explanation: In this Chapter –

- (i) “College” means an affiliated College, but does not include a Government College;
  - (ii) “teacher” means a permanent teacher, whether whole-time or part-time, and includes a temporary teacher working in a vacancy against a permanent post and also includes a demonstrator.
- (2) In every Teachers’ Council the Principal of the College concerned shall be the Chairman. At a meeting of Teachers’ Council, in the absence of the Chairman,
  - (a) The person in charge, if present, shall act as Chairman and
  - (b) Where the person in charge of the College is also absent, the members present shall elect one of their members to act as Chairman
- (3) In every Teachers’ Council there shall be a Secretary who shall be a teacher of the College concerned, not being the Principal or a Vice-Principal thereof, and shall be elected in accordance with the provisions hereinafter contained.
- (4) At the commencement of every academic year the Principal of every College shall convene a meeting of the Teachers’ Council thereof, after giving at least seven days’ notice to the members specifying therein the date, time and place of the meeting, for the purpose of electing the Secretary of the Council.
- (5) At the meeting convened under paragraph (4), the members of the Teachers’ Council shall elect, by ballot, one of its members, not being the Principal or a Vice-Principal, to act as its Secretary. The term of the Secretary of the Teachers’ Council elected under this paragraph, shall be one year from the date of his election and shall include any period that may elapse between the expiry of the said period of one year and the election of his successor.

## **9. Meetings of Teachers’ Council:**

- (1) Meetings of a Teacher’s Council shall be convened by the Secretary or, in his absence, by the Chairman, of the Council, on such dates and at such times and places as may be determined by the Chairman, after giving at least three day’s notice thereof to the members. In cases of urgency the Chairman may convene meetings of the Council at shorter notice. A meeting shall also be convened on requisition in writing by at least one-third of the total number of members of the Council and the date, time and place for such meeting shall be fixed by the Chairman and notified to the members in the manner referred to above.

- (2) The agenda for every meeting of a Teachers' Council shall be prepared by the Secretary with the approval of the Chairman or, in his absence, of the person in charge of the College.
- (3) The Secretary of a Teachers' Council shall prepare and maintain in his custody, the minutes of all meetings of the Council and the minutes so prepared shall be presented for confirmation at the next meeting of the Council.
- (4) All matters shall be decided at meetings of a Teachers' Council by votes of the majority of the members present. In the case of an equality of votes, the person presiding shall have a second or casting vote.
- (5) For a meeting of a Teachers' Council, one third of the total number of members of the Council to the nearest whole number shall be a quorum.

### **10. Functions and Duties of Teachers' Councils:**

The functions and duties of every Teachers' Council shall be to advise the Principal of the College concerned on all academic matters including students' welfare, arrangement of timetable, conduct of examinations (including University Examinations), improvement of the Library, Laboratories and teaching facilities of the College.

## **CHAPTER-IV**

### **MINIMUM QUALIFICATIONS FOR APPOINTMENT AS PRINCIPALS AND TEACHERS INCLUDING UNIVERSITY TEACHERS**

#### **Part-I Principals**

### **11. Principals of Affiliated Colleges:**

- (1) The academic qualifications for appointment to the post of Principal of an affiliated College (Education Department Order No. 118-Edn (CS) dated 17.01.79) shall be –

(2) Teaching experience of ten years when the applicant possesses Doctorate degree.

(3) Minimum age prescribed for the post of a Principal is 40 years and the maximum age is 55 years.

(4) In the matter of selection of candidates for appointment to the posts of Principals in non-Government Colleges due priority and weightage should be given to those who have secured higher percentage of marks in different examinations.

## PART-II TEACHERS FOR COURSES OF POST-GRADUATE STUDIES

### 12. Teachers for courses, of Post-Graduate Studies including University Teachers

(1)	(A)		The minimum qualifications for appointment as teachers for courses of Post-Graduate Studies in the Faculty of Arts and Commerce and in the Faculty of Science in the University/ the University Colleges and in other Colleges permitted to provide instruction in Post-Graduate Courses of Studies shall save as hereafter in this Regulation otherwise provided, be –
		(a)	A Doctorate's degree in relevant subject or research work of an equally high standard; and
		(b)	Good academic record with at least second class (C in the seven point scale) Master's degree in a relevant subject from and Indian University or an equivalent degree from a foreign university.
			Provided that if the selection committee is of the view that the research work of a candidate as evident either from his thesis or from his published

(2)		The minimum qualifications for appointment as teachers for courses of Post-Graduate Studies in Law in the Faculty of Arts and Commerce, in the University College or any other Law College shall be – "LL.M. Degree with good academic record:

		Provided that these qualifications may not be insisted upon where the University appoints a practicing Advocate as a part-time Lecturer.
(3)		The minimum qualifications for appointment as Teachers for course of Post-Graduate Studies in Library Science in the Faculty of Arts and Commerce shall be –
	(a)	A Doctor's degree or research work of an equally high standard; and
	(b)	Good academic record with at least second class (C in the seven point scale) Master's degrees from an Indian University or an equivalent degree from a foreign university. Having regard to the need for developing interdisciplinary programmes, the degrees in (a) and (b) above may be in relevant subjects.
(4)		The minimum qualifications for appointment as Teachers for courses of Post-Graduate Studies in Education in the Faculty of Arts and Commerce shall be –
	(a)	A Doctor's degree in Education or Research work of an equally high standard; and
	(b)	Good academic record with at least second class (C in the seven point scale) Master's degree in a relevant subject from an Indian University or an equivalent degree from a foreign university.

	(a)	A Doctor's degree in any university discipline or research work of an equally high standard; and

	(b)	Two years research or professional experience or evidence of creative work and achievement in his field of specialization or a combined research and professional experience of three years in the field as an artist or outstanding talent.

		A traditional or professional artist with highly commendable professional achievement in the subject concerned.
(6)		The minimum qualifications for appointment as teachers for courses of Post-Graduate Studies in Foreign Languages in the Faculty of Arts and Commerce shall be
	(a)	A Doctor's degree or research work of an equally high standard; and
	(b)	Good academic record with at least second class (C in the even point scale) Master's degrees from an Indian University or an equivalent degree from a foreign university.
		Having regard to the need for developing interdisciplinary programmes, the degrees in (a) and (b) above may be in relevant subjects.
		Provided that if the Selection Committee is of the view that the research work of a candidate as evident either from his thesis or from his published work is of very high standard, it may relax any of qualifications prescribed in (b) above.
		Provided further that if a candidate possessing a Doctor's degree or equivalent research work is not available or is not considered suitable, a person possessing a good academic record may be appointed provided he has done one year post M.A. diploma course in the teaching of foreign language concerned from a university on the condition that he will have to obtain a Doctor's degree or give evidence of research work of equivalent high standard within eight years of his appointment, failing which he will not be able to earn future increments until he fulfils these requirements.
(7)		Nothing contained in paragraphs (1) to (6) above shall prevent a person from being appointed as a Teacher for courses of study in any subject, if, with the concurrence

14. Teachers for Courses of Undergraduate Studies in Commerce

Subject to the provisions of Clause 13 above,

- (1) The minimum qualifications for appointment as teachers, other than tutors, for courses of Undergraduate Studies in Commerce in affiliated colleges shall, in respect of the subjects specified in column I of the table below, be such as are specified in the corresponding entries in column II of that table.

### 15. Teachers for Courses of Undergraduate Studies in Veterinary Science and Animal Husbandry.

The minimum qualifications for appointment as teachers for courses of Undergraduate Studies in Veterinary Science and Animal Husbandry in affiliated Colleges shall be –

- (a) for teachers in Dairying –
  - Bachelor's Degree in Veterinary Science of a recognized University or Diploma in Veterinary Science or Degree in Agriculture, dairying or Animal Husbandry or I. D. D. with at least three years' teaching experience of the subject in a recognized Veterinary College, preferably with experience of running a well-established dairy farm;
- (b) for teachers in Bio-Chemistry –
  - (i) Bachelor's Degree in Veterinary Science of a recognized University or Diploma in Veterinary Science with at least three year's experience of Bio-Chemical work in some recognised Institutions; or
  - (ii) M.Sc. degree in Bio-Chemistry or Physiology with research experience or teaching experience in a recognized institution;
- (c) for teachers in other subjects –

Bachelor's degree in Veterinary Science of a recognized University or diploma in Veterinary Science with at least three years' teaching experience of the subject concerned in a recognized Veterinary College or five years of professional experience.

#### **16. Teachers for Courses of Undergraduate Studies in Law:**

Subject to the provision of Clause 13 above, the minimum qualifications for appointment as teachers for courses of Undergraduate Studies in Law in affiliated Colleges shall be –  
L.L.M. Degree with good academic record, provided that these qualifications may not insisted upon where the University appoints a practicing Advocate as a part-time Lecturer.

#### **17. Teachers for Courses of Undergraduate Studies in Music:**

Subject to the provision of Clause 13 above, the minimum qualifications for appointment as teachers for Under-graduate Studies in Music in affiliated Colleges shall be –

- (a) Sangit Nipuna of Bhatkhande Vidyapith, Lucknow; or
- (b) Sangitaratna of Madhaba Sangit Vidyalaya, Gwalior; or
- (c) a degree or diploma in Music of a recognized University of Institution.

### **PART-IV GENERAL**

#### **18. Savings:**

Nothing contained in this Chapter shall affect appointments, other than temporary appointments, to posts of Principals or teachers of the University, where such appointments were made prior to the commencement of these Regulations.

#### **19. In this Chapter, unless the context otherwise requires –**

Interpretation

- (1) "allied subject" in relation to any subject mentioned in any of the following items, means any other subject mentioned in that item:
  - (a) Pure Mathematics and Applied Mathematics;
  - (b) Pure Chemistry/Bio-Chemistry/Applied Chemistry/Agricultural Chemistry, Chemical Engineering and Chemical Technology.
  - (c) Pure Physics, Applied Physics, Radio-Physics and Electronics and Applied Mathematics;
  - (d) Economics, Economics and Political Philosophy (Group A)

(e) Political Science, Economics and Political Science (Group B), and Political Economy and Political Philosophy (Group B);

Provided that relevant Faculty Council for Post-graduate Studies or Council for Under-graduate Studies may, by order, specify any other subjects which are allied to one another or to the subjects mentioned in any of the items in this Clause;

(2) “Demonstrator” means a teacher who conducts practical classes in any Science subject,

(3) “Tutor” means a teacher who gives tutorial lessons in any subject.

## **CHAPTER-V MISCELLANEOUS**

### **20. Continuance of certain provisions of Regulations, etc. applicable to the former University**

(1) Save as otherwise specifically provided in the Statutes, the Ordinances or these Regulations, the provisions relating to the conduct of University examinations, the passing of Examinations for the conferment and award of degrees, diplomas and certificates, the courses of study and the division of subjects and the conditions for carrying on research and for admission to different courses of study and examinations, including the manner of exemption from pursuing courses of study for admission to examinations, contained in any orders, rules or regulations, by whatever name called, applicable in respect of the University established under the Calcutta University Act, 1979 (hereinafter referred to as the former University) and in force immediately before the appointed day shall in so far as such provisions are not repugnant to the provisions of the Act, the Statutes, the Ordinances or these Regulations, apply in respect of this University and be deemed to be provisions of these Regulations as if herein made and shall continue in force as such until altered, amended or repealed.

(2) Except in so far as the relevant Faculty Council for Post-graduate Studies or Council for Under-graduate Studies may otherwise direct, examinations which were regarded by the former University immediately before the appointed day as equivalent to various examinations of that University shall, after the appointed day, be deemed to be equivalent to the corresponding examinations of the University. The relevant Faculty Council for Post-graduate Studies or Council for Under-graduate Studies may also from time to time recognize other examinations to be equivalent to examinations of the University.

21. Notwithstanding anything contained anywhere else in the Statutes, Ordinances or Regulations, a candidate for any public examination leading to a degree, diploma or certificate of this University may apply to the Controller of Examinations for reexamination of his/her answer-scripts within one month of the date of the receipt of the marksheet in the prescribed form together with a fee of Rs. 15/- per paper subject to the following conditions:

(i) An unsuccessful candidate will be allowed to apply for re-examination in not more than two papers of an examination provided he/she secured at least 45% marks on an average in the other papers of the examination; provided further that an honours candidate will be allowed to apply for re-examination in not more than two papers in the honours subject as also in not more than two papers in the pass subjects in which he/she has failed if he/she secured at least 45% marks on an average in other pass papers of the examination and 50% marks on an average in other honours papers of the examination, as the case may be.

A successful candidate will also have the option of getting his/her answer-scripts re-examined in not more than two papers, provided he/she has secured 50% or more marks in the aggregate, excluding the paper or papers in which re-examination is desired.

In case of Honours students the percentage shall be completed in Honours papers only, if they seek re-examination of Honours papers.

Applications for re-examination shall be restricted to the theoretical papers only of the regular annual examination (and not of any compartmental, supplementary or special examinations) and no application for re-examination in any practical or oral examination or internal assessment shall be entertained.

22. The Board of Examiners for such re-examinations will be appointed by the Vice-Chancellor in consultation with the Head of the Post-graduate department of the subject concerned and will have the full authority to revise the marks, if considered necessary, (the original examiner/examiners shall not be included in the Board of Examiners). The Board of Examiners shall submit the marks to the Controller of Examinations for declaration of the results accordingly with the approval of the Vice-Chancellor.

### **23. Power for general addition of marks etc at examinations:**

(1) The Faculty Council for Post-graduate or Council for Under-graduate Studies concerned shall have power generally to add to the marks obtained by candidates in a subject or paper at any examination in exceptional circumstances to be specifically recorded, and on the recommendations of the examination Board, where there is one, or the body of examiners where there is no Examination board, and not otherwise.

(2) Notwithstanding the provisions of paragraph (1), if the Faculty Council for Post-Graduate or Council for Under-Graduate Studies concerned is in any case satisfied that injustice has been done or is likely to be done to candidates at any examination in view of the fact that the question paper set in a subject is stiff or lengthy or comprises questions beyond the scope of the prescribed syllabus or contains errors, printing or otherwise, the Council may issue such directions as it may consider necessary

### **24. Prohibition for appearing at two or more examinations in any academic year.**

No. candidate shall ordinarily be entitled to appear at two more examinations in the same academic year. If any candidate, on submitting fees and forms for two or more examinations to be held in any academic year, obtains admit cards in respect thereof but eventually cannot appear at any of such examinations on the ground that such examinations are held on the same day, the University shall not be in any way responsible for such inability on the part of the candidate:

Provided that in such case the candidate may apply in writing to the Controller of Examinations for cancellation of his examination at which he so fails to appear and claim a refund of the fees paid in respect thereof with such deductions as the Council may determine.

Explanation : In this Regulation-  
“ examination” does not include any examination for admission to which a Bachelor’s degree is a necessary qualification.

### **25. Emergency meetings of certain authorities of the University.**

Notwithstanding anything to the contrary contained in Chapter II, in case of emergency, meetings of Faculty Councils for post Graduate Studies or Councils for Under-Graduate Studies and Boards of Studies attached to such Councils may be convened by the Registrar under the direction of the Vice-Chancellor on such dates, at such times and places and with such notice as the Vice-Chancellor may think fit.

### **26. Interpretation.**

In the case of any doubt or difficulty as to the interpretation of these Regulations, the matter shall be referred to the Vice-Chancellor and his decision thereon shall, subject to the provisions of the Act, be final.
